Skate Canada - Saskatchewan Nominating Committee is receiving Nominations/recommendations for the following positions on the Board of Directors for the 2008/2010 seasons:

Evaluators / Judges Chairperson (2 years)

It shall be the duty of the Chairperson of the Judges / Evaluators Committee to ensure that the Committee reviews requests for appointment and promotion of evaluators and judges as recorded thereon; recommends judges and referees for appointment to Championship panels; initiates through Skate Canada Judges / Evaluators Committee disciplinary action required for an evaluator or a judge in the Section.

Data Specialist's Chairperson (2 years)

It shall be the duty of the Chairperson of the Accountants Committee to appoint the Chief Accountant and accountants for Sectional Competitions held within the Section and all Provincial Competitions. The Chairperson will appoint the Chief Accountant for all competitions within the Section; to organize and develop programs for accountants training, to make recommendations regarding appointments, promotions or removal from the official list of accountants, to receive reports from Chief Accountants as per Rule 10.9 and maintain activity records of accountants within the Section; and to co-ordinate all accountant matters of the Section.

These positions shall be selected by the Board of Directors and elected to the Section Board of Directors by acclamation and ratified by the general membership. These appointments are subject to the confirmation of and appointment to the National Committees.
